CMS EP Rule Updates

As you know, CMS recently issued the <u>Emergency Preparedness Requirements for Medicare and Medicaid Participating Providers and Suppliers Final Rule.</u> ASPR TRACIE is working closely with CMS to provide technical assistance and share resources and promising practices.
