CMS Emergency Preparedness Rule Updates

Newly Released: <u>CMS Interpretive Guidance.</u> CMS released an Advanced Copy of the final interpretive guidelines and survey procedures that support the adoption of a standard all- hazards emergency preparedness program for all certified providers and suppliers. The final CMS guidance will be incorporated in the State Operations Manual (SOM) within the next several weeks. This guidance also addresses the unique differences of other providers and suppliers.

The Yale New Haven Health System Center for Emergency Preparedness and Disaster Response recently updated their <u>CMS EP Rule Crosswalk</u> which maps the association between the CMS EP Rule Conditions of Participation and existing regulatory and accreditation standards.

WannaCry Updates

May was a very busy month for many of our stakeholders as healthcare facilities around the nation and globe became aware of "WannaCry," ransomware used in an international, e-mail-based cyberattack. ASPR TRACIE Webinars

Recent shortages of multiple medications frequently used in the care of critically ill patients have challenged hospitals and EMS systems. On June 8, the Association of State and Territorial Health Officials (ASTHO) and ASPR TRACIE hosted <u>Clinicians and Coalitions: A Conversation about Finding Solutions for Medication Shortages</u>, a webinar featuring practitioners and speakers from state public health, ASPR, and the U.S. Food and Drug Administration (FDA) sharing strategies that can be employed to address these pharmaceutical shortfalls.

On May 24th, ASPR TRACIE and the National Ebola Training and Education Center (NETEC) hosted a webinar on <u>Highly Pathogenic Infectious Disease Exercise Planning for</u> <u>Frontline Facilities</u>. Tailored for participants from Frontline Facilities (e.g., acute care hospitals and other emergency care settings, such as urgent care clinics and critical access hospitals) that have *not* been designated as Ebola Treatment Centers or Assessment Hospitals, this webinar featured NETEC's suite of free, fully customizable, Homeland Security Exercise and Evaluation Program (HSEEP)-compliant exercise materials.
