# I. Local Health Department Emergency Operations Plans

Confederated Salish and Kootenai Tribes, Disaster and Emergency Services. (2010). <u>Emergency Operations Plan Confederated Salish & Kootenai Tribes, Montana</u>.

This plan provides a framework for tribal personnel to prepare for, respond to, and recover from natural and human-caused disasters. **NOTE**: This resource is specific to tribal areas.

Fairfax County Office of Emergency Management. (2015). <u>Fairfax County Emergency</u> Operations Plan.

This multidisciplinary all-hazards plan establishes a comprehensive framework for the management of major emergencies and disasters within Fairfax County (VA). It is comprised of a base plan, appendices, support annexes, and emergency support functions.

Merced County Department of Public Health. (2017). Medical / Health Emergency Operations Plan.

This EOP was developed to assist the Merced County (CA) Department of Public Health and other medical and health personnel throughout the county plan for, respond to, and recover from a natural disaster or human-caused event. It provides a framework for the Medical/Health Branch of the County's Emergency Operations Center and the Departmental Operations Center of the Health Department. It is a support document to



the <u>Merced County Operational Area Emergency Operations Plan</u>, which was developed by the Merced County Office of Emergency Services.

San Diego County, Office of Emergency Management. (2022). <u>Annex E: Public Health</u> Operations.

Annex E is the EOP for San Diego County's health department and is one of several departmental EOPs for the overall San Diego County Emergency Operations Plan.

Stanislaus County Health Services Agency. (2016). <u>Public Health All-Hazards Emergency</u> Operations Plan.

This all-hazards plan provides a framework for public health emergency response in Stanislaus County (CA). It identifies the roles and responsibilities of the local health department and its partners.

This all-hazards plan establishes a framework for public health and medical personnel to respond to incident occurring in the State of Florida.

This all-hazards plan establishes a comprehensive framework for the management of major emergencies and disasters within the State of New Mexico.
