

ASPR TRACIE Technical Assistance Request

Response Date: 18 November 2019

Request:

The requestor is assisting two critical access hospitals in navigating a path toward improved emergency preparedness and response capabilities. He requested checklists, orientation materials, primers, or other resources that could be used for entry-level training for hospital emergency management coordinators.

Response:

ASPR TRACIE reviewed existing resources, including those in the [Emergency Operations Plans/ Emergency Management Program](#), [Rural Disaster Health](#) (which includes a Critical Access Hospitals subcategory), and [Training and Workforce Development](#) Topic Collections. Previous [technical assistance requests](#) were also reviewed.

Section I features ASPR TRACIE developed resources and completed technical assistance requests appropriate for orienting an individual to emergency management, including a generic hospital emergency preparedness coordinator position description that identifies relevant training and typical duties.
