I. Policies and Regulations

Bruno, A. (2015). <u>Refugee Admissions and Resettlement Policy.</u> Congressional Research Service.

This report provides information on the U.S. process for refugee admissions, and addresses the various Federal government agency's roles and regulations as it relates to U.S. policy.

*Office of Refugee Resettlement. (2015). Children Entering the United States Unaccompanied.

This policy document is a summary of Office of Refugee Resettlement (ORR) policies for the placement, release, and care of unaccompanied children in ORR custody. The guide is for members of the public and other stakeholders, and is organized into the following three sections: 1) placement in ORR care facilities; 2) safe and timely release from ORR care; and 3) review of required services including healthcare services, legal services, post release services, and unusual circumstances.

Office of Refugee Resettlement. (2012). The Refugee Act.

This webpage describes the Refugee Act of 1980, which created the Federal Refugee Resettlement Program to provide for the effective resettlement of refugees and to assist them in achieving economic self-sufficiency after arrival in the U.S. It also identifies the roles and responsibilities of the Office of Refugee Resettlement, which was established within the Department of Health and Human Services.

United Nations High Commissioner for Refugees. (2007). <u>Handbook for Emergencies (Third</u> <u>Edition).</u>

This handbook covers many aspects of emergency planning and management of refugees. It is divided into the following sections: 1) United Nations High Commissioner for Refugees (UNHCR's) mandate of international protection and the principles of emergency response; 2) emergency management; 3) vital sectors and problem areas in refugee emergencies (e.g., health, food, sanitation and water), and key field activities underpinning the operations (e.g., logistics, community services, and registration); and 4) guidance on the support to field operations, primarily administration and staffing. The appendices include a "Toolbox" which provides the standards, indicators, and useful references used throughout the handbook.

United Nations High Commissioner for Refugees. (2011). UNHCR Resettlement Handbook.

This handbook provides resettlement management and policy guidance to United Nations High Commissioner for Refugees (UNHCR) staff, and is a key reference tool on global resettlement policy and practice for resettlement countries, non-governmental organizations, and other partners.

III. Lessons Learned from Real Events

Georgetown University Law Center, Human Rights Institute. (2009). <u>Refugee Crisis in America:</u> <u>Iraqis and Their Resettlement Experience.</u>

This report addresses the domestic side of the refugee situation, focusing on Iraqis that have resettled in the U.S. It discusses the United States Refugee Admissions Program (USRAP), and determines the extent to which Iraqi refugees have been afforded protection and a durable solution for resettlement through the USRAP. The author's provide the findings of their research, and recommendations for improving issues faced by refugees, and the programs that serve them when resettling in the U.S.

Newland, K., Tanaka, H., and Barker, L. (2007) <u>Bridging Divides: The Role of Ethnic</u> <u>Community-Based Organizations in Refugee Integration.</u> Washington DC: Migration Policy Institute, and International Rescue Committee. This report examines the refugee resettlement process in the U.S, and in particular addresses the role of ethnic community-based organizations (ECBOs) as drivers of refugee integration. Authors of the report discuss their findings, including how ECBOs are adept at identifying and responding to the diverse needs of refugees across various stages of integration, and the challenges that refugees face.

U.S. Army Command and General Staff College. (n.d.). <u>Commander's Guide to Supporting</u> <u>Refugees and Internally Displaced Persons.</u> (Accessed 10/20/2017).

This handbook provides insight into the military's role in dealing with refugees and displaced persons. It includes several articles written by students from the U.S. Army Command and General Staff College. The articles describe their experiences, and the problems that military commanders and units faced when in operational environments dealing with refugees and displaced persons.
